

## KENDRIYA VIDYALAYA NTPC FARAKKA

### MINUTES OF VMC MEETING HELD ON 28.08.2017

A meeting of VMC was held on 28.08.2017 at 10.00 AM in Library room of the Vidyalaya premise. The following members were present and discussed different issues mentioned in the Agenda point.

1. In the beginning Principal Sh. Rajesh Dwivedi welcomed the members and informed about the main goal of the meeting. Principal Sh. Rajesh Dwivedi took up the minutes of the previous meeting one by one point wise and informed the members that almost all the decision of previous meeting have already been implemented.  
The nominee Chairman Sh. P.R.Deb Barma and all other member expressed their satisfaction that except one or two issues all decision have been implemented.
2. Then Sh, S.C.Saha with the permission of the principal informed the members the result of last Board Exam i.e. X, XII 2017 and the performance of the Vidyalaya.  
It was advised by the nominee Chairman and some other members that Vidyalaya should try to improve the performance further in the next year.
3. Regarding approval of Revised Budget estimates Principal Sh. Rajesh Dwivedi informed the members that it has already been approved by the committee in the previous meeting of February.
4. The Principal informed the members that the Vidyalaya building needs an urgent Painting and white washing as the last time it was done more than three years back and at present it looks very dull from outside due to the black spots on the walls.KVS authority always emphasizes on a very bright and vibrant appearance of the Vidyalaya building.  
Sh P.R.Deb Burma the nominee chairman asked the parent member and Asstt.manager (civil) township administration Sh. S.Adhikari as to could how it be done at the earliest?  
Sh. Adhikari informed that a proposal in this regard is already there for all the non-residential buildings and the work will be expected to be completed soon.
5. Principal Sh R.Dwivedi informed the members about the works completed during the last six months-which includes setting a separate toilet for special children,completion of repairing of library tables, purchase of library books,repairing of electrical fittings and toilets and white washing of the other building from inside.

6. Principal informed in detail the planning made to improve the performance in 2017- 18 CBSE Exam to X & XII. Members expressed satisfaction.
7. Regarding the enhanced pay structure after 7<sup>th</sup> CPC, Principal Sh. Rajesh Dwivedi informed the house that KVS authority has given the instruction to implement the recommendation of 7 CPC positively from 01.01.2016, but the enhanced new pay will be given from the salary of August 2017, As a result the employees will receive their arrear payment from 01.01.2016 to 31.07.2017, So the NTPC authority should release that additional fund to the Vidyalaya along with the rest of the amount get to be received as per the original budget proposed submitted in April 2017.

At this Sh. Arnab Mukherjee, manager HR and member VMC suggested the Vidyalaya should submit an exact amount of arrear at the earliest so that approval can be obtained from the higher authority which will take the payment arrear.

8. Regarding the installation of AC in Library and office the Nominee Chairman and the members agreed and suggested that the same may be done from the Vidyalaya Fund and it should be 3 Nos and each of 2 ton capacity.
9. The Principal informed the members that the Vidyalaya faces sever water crisis during the summer as the water cooler have become very old and getting out of order frequently. Nominee Chairman and members approved the proposal and asked to process the same following the purchase procedure.
10. Principal informed the house that a large number of damaged furniture and other items are needed to be condemned and disposed of immediately as they are not only unservicable but also occupy many rooms .  
— Sh. Arnab Mukherjeesaid that he will make arrangement to take these articles back as early as possible as these articles were given by NTPC.
11. (i) The chairman and other members approved the purchase of 02/03 nos of LCD projectors As per the decision of previous meeting. The chairman gave his consent for the same.  
(ii) Sh Arnab Mukherjee requested Sh. Debburma to help in getting the amount Rs 50,0000/= for the Vidyalaya from NTPC.
